I use PCC computers to check my student records, to do homework, etc. I am not a lawyer, but I did work in the publications department of Lewis & Clark College for 5 years, helping to manage the University website, so FERPA was something I was (and am) concerned with. My understanding was, and is, that several things related to my computer use, including the classes I am taking, my student loan info, and other potentially private information - is protected under FERPA.

Perhaps I am wrong and someone better versed in the law can explain the details to me.

All that aside, having my course work altered and deleted as I am working on it, or having old versions saved over new versions by outside parties is no small matter. That is basically what is, and has been going on.

Hopefully just asking for it to end will help bring a close to it.
