I, my partner of almost eleven years, and my daughter are being held hostage in inhumane and I believe deadly conditions in Portland, Oregon. It's being done in such a way that of all three of us, I seem to be the only one aware of how serious the situation is.

I have experienced decades of what I had thought was health problems of unknown origins, and what now understand is torture enacted by hospital systems at the behest of outside entities, some of which I have identified. My daughter and my partner have experienced similar types of torture, but again, are unaware of the origins. The medical systems have covered for these crimes by falsifying my medical history so I would appear to have mental disorders rather than life-endangering medical issues related to crime.

Beginning about July 2017 I began to notice a lot of strange aircraft around me, and it became clear that what appeared to be stars in the sky were in fact a network of drones, some even forming spoofed constellations.

In addition to this, I began to experience what were clearly electronic or frequency based attacks to my head and body, later to my heart, lungs, neck, throat, etc. Around August 1, 2018 various sorts of implanted devices were activated all around my body so that I could feel "tugging" sensations in the places where they were located, including at least two devices in my gut, devices in my throat, and all through my arms, legs, hands, eyes, nose, head, teeth, and in all my mucous membranes.

In October of 2018 I purchased a good quality radio frequency tracer called Aceco FC-6002 MKII and with this device, I was able to confirm the presence of radio frequencies emitting from different locations in my body, as well as from locations throughout my apartment. I felt this was important confirmation of what I'd already understood to be true, but it didn't seem to help in terms of getting outside assistance. In fact, a lot of things were being done to create confusion around this, one of the most significant being the sudden appearance around 2016 of a large group of people online claiming to be "targeted individuals" and reporting similar things to what I had been experiencing, often either right before or right after I'd experienced these things. This caused me to believe that what I was experiencing was not unique. I now believe that the "targeted individual" phenomenon is mostly disinformation. I suspect that many of the people making these claims are directly involved with the group or groups which are generating profit by keeping me captive and by trafficking me in different ways.

Beginning about April 2018 I was contacted, albeit covertly, by a group that I was made to understand is linked to US Army intelligence. No one contacted me directly in a face to face manner - all the communications have come through covert means, mostly sounds and telepathic types of transmissions that must be linked to some of the transponders in my head. The telepathic transmissions have been the most powerful in terms of conveying information, and these include different forms of visual telepathy, thought telepathy, and dreams. Through these means I was helped to understand more about how my situation evolved over the years, and maybe most importantly, I came to understand that my dreams had been programmed over my entire life, and that the imagery in my dreams is not symbolic, but in code. This is significant because I had been writing down my dreams pretty regularly since 1983, and I remember dreams going back to about 1971.

This group, which I will just call "the Army" as that's my best understanding of who it is - made me understand that the situation around me is, and has been deadly to many people over the years, and that it is deadly to me. This was made very clear to me by June 2018, but they also made it clear that they were limited in their abilities to help me, I guess by some prior agreement, and that this was all related to Freemasonry. I was given a vague idea of how this may have all evolved, and how key junctures in American history may have solidified it. I had by this point already been aware that both I and my partner are being held in this way due to a multigenerational tradition that is important to a lot of people culturally, and it appears, also financially. Thus, regardless of how this started, it is now pretty clearly an entrenched form of slavery, and as with chattel slavery of the earlier days, there is a significant group of people who are determined to continue the system, regardless of the human cost. To this end, I have been made to understand there are, and have been, active efforts to assassinate me, my partner, and ultimately my daughter via frequency based technologies. And I have been shown how easy it is to do this, and how much it already happens.

One of the things I learned from the Army is that many of the frequency-based technologies being used on me were developed by NASA and are somehow linked to postwar rocket programs which employed scientists brought over from Nazi Germany. I learned that these technologies have been used to manipulate our bodies in various ways, including sexually. I also learned that these technologies were used to hold one of my childhood friends in a comatose state for many years, that he was trafficked in various ways during this time, both to the medical and to the entertainment industry, and I learned that there are other people currently being held in this way and likely also being trafficked from hospitals in California.

From my perspective, what I am seeing is insanity.

The idea that a large group of people can hold a small group of people captive, deprive them of all their human rights, manipulate and torture them in this manner, and then kill them at will, is not only insane, but the structure built around it is effectively destroying everyone's rights. For example, even though I'm an American citizen, all my rights to life, liberty, and due process have been severely interrupted. I am being abused by doctors and by dentists, all of whom appear to be answering to an outside entity. People who I've known my entire life, who I've considered my friends, do not even feel safe telling factual truths about me if it means those truths will enrage who ever is holding me captive, and for good reason - there have been many assassinations around me. Meanwhile, there is a lot of open bribery and corruption going on intended to ensure continuation of the system.

In addition to medical torture, group harassment, and economic blacklisting, I've been forced to witness torture and assassinations of my pets, especially cats, and I've been made to understand that the part of this "master plan" is to have me, my boyfriend, and my daughter meet this same fate.

This is an appeal to stop the insanity.

I personally believe that the road out of this is to activate and enforce all existing laws that are currently being ignored in order to facilitate this crime at a systemic level, and to enact immediate consequences for civil servants who refuse to do so - specifically job loss.

With regards to corruption in the medical industry with regards to my own medical treatment, it's possible there is a single individual manipulating this. It does appear that there is a single entity manipulating it. Also, I am aware that surveillance images of me have been trafficked from hospital rooms, including images

of me, disrobed, seeking help for microwave weapons burns to my face at OHSU dermatology department in April 2018 and images of me giving birth to my daughter at Mad River Hospital in California, December 11, 1995.

Because of the severity of the situation, and because it seems clear that we are now in immanent danger of assassination, I am asking right now for a rescue plan to be made and enacted. It seems that the systems designed to protect American citizens from normal crimes have all been subverted and are being used to actually continue this crime, and to bring us to a terminal conclusion in violation of all our rights - human rights and constitutional rights. For this reason, I think we should be viewed as endangered hostages and that swift, appropriate action should be taken to ensure our safe rescue. I personally don't believe that under current circumstances this can come through normal systems such as police, etc. I think this needs to be looked at for what it is, a multinational crime that may require decisive military intervention.
