What was the exact crime that occurred?

This is a multipart crime involving public corruption which is why I cannot speak with police and why public officials have also not been helpful, but the biggest concern right now are ongoing attacks on my body via frequency-based weapons which at this time seem to be coming from drones and antennas, and it has been made clear to me that the intent is to kill me, probably via induced cancer, and to kill my partner Chris Newman, probably through a cardiac event.

I have amassed a tremendous amount of evidence over the past six years in the form of radio frequency scans of my body and apartment (some of which I videotaped), photographs of injuries, photographs of implants visible under my skin, written narratives and journals. My medical records have been fabricated and falsified in order to cover this crime.

Did you suffer any personal losses (financially or physically) due to the crime?

I've suffered tremendous loss, since this has been going on to some extent my whole life - I understand I have been trafficked via surveillance and also medically, including surveillance trafficking from hospital rooms. My body has been irreparably damaged, some of which I've shown and described on video.

How long has this activity been going on?

I can tell that frequency-based attacks have been occurring over my entire life, however, it's gotten worse and worse and right now it's been made really clear to me that the intent right now is to end my life and my partner's life.

What specific details do you have to report about the crime/incident? (Additional information regarding what, why, and how)

Even though I believe we are in imminent danger, I can't report this to police, because it appears the police as well as nearby hospitals have been involved in this crime the entire time, and reporting the crime puts me in danger. My medical records are full of fabrications - fabricated quotes, fabricated observations, and false diagnoses used to discredit me. This creates a chilling effect on my ability to describe everything I know and how I know it - even to people who already know I'm telling the truth, like police or doctors. It appears that various people in the community are able to send directed energy to some of the transponders in my head and body, and that implants of particular concern are implants in my digestive system (small intestine, probably), an implanted crown manufactured and placed by Willamette Dental which they have so far refused to remove, and implants around my breasts and lungs. My partner and I have also both been attacked in the heart - in my case, the attacks to my heart were timed in such a way that I would know they were directed energy attacks - in his case, there were similar tells that I could see, but he doesn't - for example, our breathing would be affected simultaneously. I have records of this kind of thing in journals going back several months.

How do you know the subject?

I have a feeling the FBI already knows more about this than I do. This is not one person doing this, it is many people. There appears to be some kind of crime hierarchy with bosses, captains, soldiers (coded as "dogs") etc. It seems to have a mafia-like structure with "taxes" being paid. It's multi-state, and I guess also multinational - but I see a lot of weird patterns with regards to out of state license plates showing up around in waves. For example, recently Portland has been full of cars from Texas. Also, there are other patterns seen around this - construction projects start up all around town, all at once, using all the same materials - and often at bizarre times (like in October or January). The surveillance trafficking part of this crime is so big it's almost openly talked about in coded speech. "Cookies" and "cake" and "drinking" are code for bribes/corruption, for example. "DE" or "lightning" is code for frequency-based attacks. "Sleeping" is code for pretending that you don't know this is going on. Again, I don't think this is anything the FBI isn't aware of, but my concern is this has been normalized

and the danger we are now in has increased significantly and people, including law enforcement, may have grown numb and are not taking this seriously. In any case, I can give more information about specific subjects I think are directly linked to attacks on me, but there are several of these that I know about, probably many I don't.

Additional information

Some of my information comes through military programmed dreams. The dreams are usually in code. If necessary, I can explain how I know this, and the basics of how it works. These dreams are not necessary as far as showing evidence of crimes - I have plenty of other evidence - what they do is provide shortcuts and give information that I couldn't otherwise get through normal means. The reason I know my life is in danger is the message and information has come to me through multiple channels - coded clues left by people in the community, manipulations of implants in my body (especially around my heart), sensations that let me know I'm being targeted with frequencies in vulnerable areas like my neck, heart, breasts, lungs. My understanding is that multiple entities are firing at me at once right now, with the intent to kill. The motive appears to be financial and the desire to continue this crime indefinitely, while I have been trying as hard as I can to end the crime, restore my rights, and get to a place of safety.

How do you know the witness?

There are definitely witnesses, but I've not yet found one who would admit what they've witnessed. For example, in January 2014 my car's electrical system was sabotaged so that it could be remotely manipulated via infrared devices affixed to other cars and trucks on the highway. Someone called (Sacramento County) sheriffs who refused to examine the car and instead sectioned me for being "gravely disabled," creating falsified reports. Meanwhile my dad tried to drive the car home at night and crashed. First he told me he crashed because the headlights failed (electrical system failure) and later he changed his story to say he just accidentally crashed, no headlight failure. Others who witnessed the different aspects of the crime behave the same way, will not even give small factual details that would help me in any way. I think this is because they are afraid, and in fact, I think there have been several strategic assassinations to ensure that witnesses stay silent. Some of these assassinations may be linked to certain police and/or sheriffs departments. So the real problem and real danger is that it's not just rogue criminals, but they're working with and through law enforcement and medical systems.

There seems to be various disinfo campaigns going on designed to cover the actual crime or crimes - one of them is a group of people who call themselves "targeted individuals." In fact, at one time, I was so worried about one of these "targeted individuals" who said her infant child was being attacked with directed energy, I submitted an FBI tip about her - so I felt pretty stupid when I realized this was disinfo. I think the point is to keep me thinking that what is happening to me is not unique, it is just something that happens to people. I think this is a large group of people profiting from trafficking a small group of people. Hospitals are being used as enforcement centers, illnesses are remotely generated via frequency-activated implants as punishments and for the purposes of insurance fraud. I have gotten information that some of the frequency-based technology used in this was developed at NASA.
