Re: Civil Rights Division report **55091-KTM** 

Immediate concern - Police, FBI are failing to protect me from crime and in fact seem to be actively involved in smearing me, discrediting my concerns, allowing doctors to misdiagnose me, and allowing various entities to try to murder me via a covert wireless body area network. I believe Portland Police and FBI are actively facilitating the crime, including hacking of our phones, distribution and trafficking of unlawfully collected surveillance, various fraudulent activities, and frequency-based attacks. We need to be protected from this crime.

To Whom It May Concern:

In this letter "Chris" refers to Christoper Lynn Newman born 1953 in Longview, Washington
I am Erika Katrin Meyer born 1968 in Friday Harbor, Washington
My daughter is Brook Morgan Thompson, born 1995 in Arcata, California

Chris, my daughter, and I have suffered severe crimes over the past several years which it is clear are intended to ultimately result in our deaths. We were all covertly implanted with medical body area networks of wireless implants (MBANs) which are used to torture and sicken us, and which can be used to kill us. I have a significant amount of evidence regarding the implant network in my own body including photos of directed energy weapons damage, a long medical history of severe pain linked to a dense network of implants in my back and neck, and frequency tracer scans showing implants throughout my body¹ as well as records of my own subjective experiences going back to early childhood. Several of our family members have been murdered through implant networks. I know this because I've learned to recognize the pattern of how implant-based illnesses manifest and there are always other clues as well (numerically signifiant dates and times and other linked situations).

Chris' mother was murdered this way last December – I know it was a murder because I was warned ahead of time in different predictive ways that she was in danger, because shortly after this she had a sudden catastrophic stroke, and because she died at exactly 11am just as her mother had died at exactly 11am.<sup>2</sup> Then Chris grew sick suddenly about a week after Christmas, was hospitalized on January 4 where he was told he had a rare, and

terminal cancer, and given 6 months to a year to live. He had both a severe gall bladder infection and cancer of the gall bladder, but it's clear to me that a lot of medical manipulations are being done to him to torment and torture him while he is ill. I believe the goal is to hasten his death.

My daughter and I have been violated, exploited, defamed, and tortured for years (in my case, decades) by medical systems. Through various means I've been made to understand that our lives are now in increased danger as well.

I discovered that there is a system of finance around these wireless frequency-based assaults and murders. With regards to the murders, it appears that wealthy benefactors who want to assassinate someone put money and other goods into a pot. A killer is hired, the assassination is carried out and then the collected payout is spread among people in a crime organization. These assassinations are done in a number of ways, usually disguised as a medical event or accident. If there is a visible homocide, it's done via a killer activated by frequency-based mind control. I've spent years collecting evidence and putting together what's been happening and have sketched out and could present several case studies showing patterns here.

With regards to how the crime has been affecting me and my family, I have tried numerous times to present my evidence to police or (more frequently) the FBI but they always tell me they "won't" or "can't" investigate this type of crime. My attempts to contact the FBI typically lead to retaliations, an increase in assaults, and often threats to my daughter. After years of this, it's begun to occur to me that FBI is actually brokering this crime and that they are working with other organized crime groups. Other participants include hospital systems – every hospital system in Portland, Oregon, for example – fire departments, first responders, charitable foundations and many industries, especially wood products, construction, automotive, food products, and perhaps most importantly, the entertainment industry.

It appears that it is the entertainment industry which has found the most value in accessing trafficked surveillance, and in manipulating families under surveillance. I believe they are also involved in many murders, including murders of children done for the purpose of creating trauma and perpetuating an occult or "esoteric" practice of molding children's personalities through trauma to be used for to be used for specific purposes (including the purpose of traumatizing others). Doctors and psychologists also participate in this.

Chris and I are both artists, and both of us have been blacklisted, but Chris is an especially talented musician and songwriter, and despite the constant blacklisting and the deeply fraudulent contracts he was subjected to, his

output continued to be prolific. He ended up recording over 70 albums, all of which were buried, sabotaged, and secretly trafficked, with many of his innovations credited to other artists, most notably, Kurt Cobain and Nirvana. Cobain's "borrowing" of ideas from Chris was obvious enough that it was the first I noticed, back in 2014. But all of us have had our lives and ideas fed into the entertainment industry and utilized in different ways. What has made this particularly damaging was the accompanying blacklisting – any artist Cobain mentioned in the 1990s, for example, could enjoy immediate industry interest and an increase in sales – but with Chris, his ideas were taken by artists who couldn't even speak his name. A related issue is Cobain's suicide which seems to have been forced to the point that it could only reasonably be called an assassination. As I've described above, a group (which I have reason to believe was Arcata California Masonic Lodge #106) called for Cobain's assassination and involved the community around him in it.

I have seen evidence that many artists and celebrities have been abused and assassinated, with signs of medical assassinations being particularly prevalent in certain communities. Generally speaking, the problem seems to be widespread and growing.

With regards to this system of calling for and carrying out assassinations in order to gain material rewards, all of Portland's local government seems to be deeply enmeshed in the system. I believe the city of Portland uses money from assassinations to fund public works projects.

I think exponentially more people know what is going on than have vocalized anything about it. It appears that their belief is the costs of speaking out are too great. So witnessed are either silenced or enticed or forced to lie. Thus, one of the ways crimes against us are covered up is by defaming me, the crime victim and person complaining about the crime. This has been done in a systematic manner through hospital systems going back several years via false psychiatric diagnoses, especially "delusional disorder" which is applied to me with the intent of discrediting anything I say that might bring attention to the crimes or to who is committing the crimes. I have several other documents addressing these false diagnoses.<sup>3</sup>

# What I'm asking of the US Government

What I would like for us is immediate assistance and the protection that honestly we should have had all along. Ideally I would like to have the MBAN addressed and to have my whole family screened, possibly by a military hospital, for damage that is typically caused by these weapons, especially potentially hidden cancers. Chris' cancer, for example, was in a location that meant it was unlikely to be discovered before it was too late. I don't want to end up in the same situation. I'd like to be screened – and protected – immediately, and I think my

daughter should be screened and protected as well.

I suspect the technology implanted in our bodies is under some type of classification, but it shouldn't be as it seems to be used almost entirely to commit crime, and my understanding is that classification cannot legally be used to commit crime, or to cover things up because they are inconvenient or embarrassing. Though my immediate concern is my immediate family, I think there are many people who are not safe right now and will not be safe until they know about and can address the implants which they may not even know are making them sick. I hope that we (my daughter and I) can address the presence of the MBANs in our bodies, how to prevent ongoing damage, and what to do about finding and addressing damage that's been done as soon as possible. In Chris' case, I don't want him to continue to be manipulated, harmed and/or assassinated. Even terminal cancer should not be used as an excuse to murder (especially considering the cancer itself was deliberately caused).

On a bigger level, with regards to this crime and the network around it, this is what I think would be appropriate:

1 US should renew its commitment to the separation of powers as well as the separation of church and state as is enumerated in the Establishment Clause and Free Exercise Clause of the First Amendment. To this end, no crime organization, club, fraternal group, or "family" should dictate how Chris, I, or my daughter are treated in any way. We should each be afforded our full rights and protections as enumerated by US law, including the right to be protected from crime. Others around us or who have witnessed crimes related to our unlawful detention should also be protected so that they are not afraid to tell the truth about us, or to us.

2 US should commit to enforcing existing laws, especially with regards to what appears to be systematic corruption operating openly. In this unlawful system, wealthy individuals and corporations have been permitted to offer rewards for specific behaviors intended to deprive another person of his or her rights. These rewards are usually referred to in coded language as "cookies" or "cake" and may take the form of cash, corporate gift cards, foundation grants, homes or home improvements, cars, vacations, record deals, book deals, good publicity - the list goes on and on. What people do for these rewards can be anything from harassment, to libel, to fraud, to malfeasance, to murder - including the instigation of, participation in, and covering up of mass casualty events.

3 US should end any and all trafficking systems built up around us and our unlawful detention including drug trafficking and weapons trafficking overseen or protected by law enforcement or other government entities, and especially the collection, distribution, and trafficking of unlawfully obtained surveillance materials. At this time it is clear that law enforcement has permitted and likely even facilitated all kinds of unlawful surveillance. This

has been and continues to be incredibly damaging, and it needs to end. No one should be having their private activities, private conversations, emails, text messages, medical records, doctors or counselors visits accessed or distributed except as is stipulated under US law and the 4th Amendment. In those instances where this is happening, this activity should be brought to a swift and decisive end, both at the surveillance level (access through phones, fire sprinklers, smoke detectors, light fixtures, "smart" devices, etc) and by completely shutting down all platforms used to distribute this data and doing whatever is necessary to ensure that such platforms stay shut down.

Generally speaking, I'm asking for protection from crime and a complete restoration of our rights, and of law and order as is articulated in the US Constitution and in State, Federal and International Law - and ONLY through these laws - no secret laws, no *Mund*, no "family" law, no "seal," no *omertá*, etc.

### **Additional details**

### observations about how the network operates

What I am seeing, especially in key areas like law enforcement and health care, but also in university systems and with private individuals who's positions are considered to be of strategic value, is not only are they offered rewards for corrupt and even murderous behavior, but they are threatened or harmed if they refuse to engage in corrupt behavior. Often implied threats and assassinations involved loved ones - spouses, parents, grandparents, children, etc. This "family" - a crime cabal - seems to regularly assassinate members of groups - families or team groups like rock n' roll bands - in order not just to profit financially, but to exact increasing control over remaining group members. Often the person who is eliminated is a relatively independent free-thinking and/or empathetic person. It also appears that this group assassinates people who are a bit older (after age 40 or 50) when they have been participating in crimes at a relatively low level over the years because they are seen as a potential liability. Often the assassinations appear to be crimes of opportunity - someone is aging, or their health is already compromised in some way, or they take certain risks or put themselves into certain situations (perhaps as the result of mind control) which can be exploited to manufacture a catastrophic or otherwise terminal event.

So much of this could be prevented simply by eliminating the system of bribery which is operating essentially out in the open, and which, like the use of wireless frequency weapons, seems to have been operating for 100 years or more. That the quid pro quo bribery system gone on this long means it's gotten powerful and sophisticated but that doesn't make it any more legitimate. It only makes it more dangerous - more of an existential threat not just to individuals but to entire families, entire communities, and to the country itself.

The manner of assassinations used by this group is disguised but not disguised so much that it cannot be detected or investigated. Murders are committed with electronic attacks, medical malfeasance, and powerful mind control weaponry which operates via wireless signals sent to implanted devices covertly placed in human bodies - soft tissues and dental work. The easiest way to detect wrong doing would be to test for MBANs. The implants in the BAN give off wireless signals.

I believe the reason why this crime continues unabated is because law enforcement and everyone who works with law enforcement has been folded into the crime network. In some cases when a person is injured in a violent encounter, medical assistance is delayed almost as if to ensure the person's death. Law enforcement routinely covers for the killers even in the face of compelling evidence that a serious - and solvable - crime has been committed.

Other stealth or covert attacks are used as well, including biological attacks - deliberate spreading of pests, parasites, and infectious disease, including the deliberate creation or exploitation of pandemic situations.<sup>4</sup>

This "family" crime network is also involved in high profile assassinations and mass casualty events. The crime system seems to be arranged such that people who are willing to pull of a particularly high profile or lucrative attack from behind the scenes are permitted to advance to a higher, more protected position in the organization.

The crime organization operates through family groups and on a multigenerational level. Children and grandchildren are initiated into the group it seems through a series of steps, probably beginning for many in grade school where they're exposed to trafficked surveillance, and then they are likely "made" right after high school by participating in, profiting from, or silently witnessing a murder.

At this point they are made to believe they are "married" to the crime family and they can never defy it. They're bound to serve the crime organization, to cover up the crimes of the organization no matter how heinous, and to honor its *omertá*, never even admitting to have heard anything bout the organization. It seems like this group has gathered together other groups that depend on secrecy including the intelligence community (classified knowledge and technology is exploited), traditional organized crime groups who honor *omertá*, and secret societies like Freemasons ("esoteric" knowledge is exploited).

This group is adept at employing mind control techniques, both psychological and via sophisticated electronic

technology. They are also able to effectively control the flow of information and disinformation. Those who resist mind control are apt to be punished and at risk of assassination. I've noticed this particularly when I'm dealing with entities I believe are linked to the entertainment industry.

Another reason for their success is that they have been able to infiltrate and overrun key groups in the public, private, academic, and philanthropic sector including law enforcement, legislative, legal, educational, journalistic, scientific, and medical professions. They seem to hold tremendous power in the entertainment industry and over the celebrity "star" system. It is likely they are also linked to the military since a lot of the technology employed is military-developed and some of the events this group has orchestrated have led to significant military engagements.

# Rights and laws currently being violated, which should be restored

1 Our constitutional rights under the First and Fourth Amendment should be restored. I know we are not the only citizens being silenced, harmed, and trafficked via unlawful surveillance conducted, overseen, or permitted by the groups working for the Department of Justice.

In the past I would have articulated claims regarding the 5th, 6th, 7th, and 8th amendments but while it is true that our due process rights under these amendments have been violated, I now realize this is less about court process and more about the United States failing to protect us from crimes, including crimes like destruction of evidence (possibly by the FBI) and a kidnapping event orchestrated by this cabal, disguised as a mental health intervention but which was actually designed to defame me and to prevent me from accessing legal counsel. The idea that has been conveyed to me that there is some kind of secret "court" or legal proceeding going on is in my opinion nothing more than a thinly veiled cover for crime and a rather disingenuous way to legitimize collection and distribution of surveillance, defamation, libel.

2. All rights under 18 U.S.C. § 3771 Crime Victims' Rights Act of 2004, most immediately and crucially, the right to be reasonably protected from the accused. A complicating factor here is the fact that law enforcement - quite possibly the entire Department of Justice - is counted here as among the accused. The only way for any entity working under the umbrella of the Department of Justice to do their job properly with regards to us or other victims of this same system is for the Department of Justice to clean house with regards to unlawful behavior, including the "enforcement" of secret laws or crime family laws which directly conflict with legitimate US law. This would include the dismantling of any and all unlawful surveillance and surveillance distribution networks, and the dismantling of disinformation networks which are operating through the "cookie" system of

bribery, especially if these networks are being run through any part of the DOJ as I believe they are. It would include the immediate cessation of related FBI black bag operations which appear to include a lot of really heinous behavior including the training and operation of civilian assassination teams. Police and FBI should be cleaned up to the point where they are not only not committing these kinds of crimes, but to the point that they are morally and ethically equipped to actually INVESTIGATE and when necessary, PROSECUTE these same types of crimes. I'm speaking here also about medical malfeasance, especially with regards to wireless technologies and body area networks.

- 3. There are a number of other federal and state laws being violated here, obviously, including privacy laws around education data, medical information (HIPAA), human subjects research laws, and of course laws against assault, fraud, human trafficking, systematic blacklisting, and murder.
- 4. Human Rights as outlined in the UN's Universal Declaration of Human Rights may not specifically be US law, but it was supported and signed by the United States who often invokes human rights when critiquing other countries. At the end of this document, I've attached a list of UDHR articles I think are being violated.

I hope you are able to see the severity of our situation and are able to offer us some help or direction, the sooner the better. Please let me know if you need any additional details, supporting evidence, or clarifications.

In 2015 I tried address falsifications in my medical records at OHSU only to have them simply refuse to make changes. Since then, there continue to be many falsifications in my medical records, some of them too bizarre and blatant to possibly be accidental. Sometimes many details are falsified or weirdly spun; often it's a few small seeming details or a misquotes, but put together, they add up to a false profile - an avalanche of misleading paperwork by "experts" impossible for me to address in any reasonable way.

4 Both I and my daughter have seem to have had pests and parasites introduced going back to childhood. Head lice were a common one for both of us. I haven't written about the head lice, and the signs that they were deliberately introduced pests, but I could. I think we've been victims of many different biological attacks over the years, both illnesses, including chronic illnesses, and pests. I have attached one document about the bed bugs which I believe were planted in my daughter's mattress around spring break 2017 while she was away at her uncle's Timmy's funeral. Timmy had been "randomly" stabbed to death in a parking lot in Klamath, California.
