Attaching a directory with some photos of injuries that seem to be from microwave weapons. Typically the burn or rash-like injuries appear in a matter of seconds, with a feeling of heat. But this has not been an ongoing issue - of greater concern are these attacks to my brain, lungs, and internal organs that have been ongoing. They're harder to show visually but I can describe them and show evidence of the effects to my brain, cognition, coordination. I believe I am experiencing a murder-by-cancer process (Murder by cancer or other induced disease). That is why it's so important to bring these attacks to a complete stop as soon as possible.

Please let me know any areas where you might need enhanced information, additional supporting evidence, or narratives. I've been keeping notes, and can explain or clarify basic science as needed. For reasons I can explain as needed, I have reason to believe ultrasonic weapons are being used to create cell damage and cancer. This may be something that can be detected with a sonogram - not a type of equipment I have access to, but considering the patterns, it may be important. I do have recorded evidence showing electromagnetic fields specifically over the seats of both chairs in my apartment, and over the pillows on my bed. An associated issue of some importance is there does appear to be some really intrusive surveillance going on, especially of my phone and computer activities, and it seems like these directed energy attacks are often retaliatory. My attempts to report to law enforcement always tend to elicit retaliation, or anything I happen to do with my phone or computer that bothers whoever is wielding the weapons.

Tonight was very rough and the past several nights, the entire past year has been bad, as far as directed energy attacks. I hope we can put an end to them quickly. I will do whatever I can do to help you get the information you need in this regard.

Hi Officer Francis, I'm just checking to confirm you received the information I sent and to see what the next steps are. This is an ongoing murder attempt, and it's a matter of time, so I'm hoping we can keep moving forward as I'm continuing to experience near constant radiation attacks and have documented evidence of some of the effects. I have good reason to believe that ultrasonic weapons are being used, that there is an attempt to create fatal cancer this way, and that this plan and behavior is not actually unknown in the Portland community. That this is financed and that there are and have been

other murders of this type going on in Portland. I'm trying not to dump too much of what I know of the backstory on you all at once because obviously I want you to work based on evidence, images, video, scientific measurements. I have evidence of cognitive effects from these weapons being aimed at my brain.

I do know that the CIA and FBI are behind these attacks, that they are being influenced by outside forces - global finance, Ahmadinejad. That there is a financed plan to murder me. The drone swarm that seems to be above Portland day and night (visible at night mimicking stars) is the biggest clue that there's something out of the ordinary going on, but there are a variety of weapons being used. I know there are ways to measure ultrasonic frequencies, as well as the other types of radiation involved.

The FBI is adamant that this is a police issue "not an FBI issue" - creating a sort of a Catch-22 since as I said, I know they are involved in these activities, and they certainly would have the tools to measure the frequencies. Because this is a murder attempt, and my life is at stake, I'm trying to address the problem despite attempts to belittle me, obfuscate the facts, or shut me down.

I spoke with you a little after 5am so it may be that you work a night shift. Many of the starlike drones are very visible at night, at least around me, and with a basic knowledge of astronomy it's very easy to see they are not stars. This is one sign that something is not normal, and that what is going on is significant, as it involves airspace over Portland. I imagine the police already know all about this swarm of starlike drones which I believe are linked to the FBI and CIA. Some of the electronic / radiation attacks are linked to the drone swarm, but some are linked to ground-based antennas and some are from ultrasonic weapons that may be located at or near ground level.

I have an idea for one thing the police could do right away which would be helpful, which is to download information from my Geiger counter to get a read of the dosimeter before it overwrites the recent radiation spikes. That way the data can be preserved and better evaluated. It registered another spike over 1000 CPM yesterday.

I myself am unable to unload the dosimeter information as my laptop PC was stolen and it is PC only. The Geiger counter is a GMC-300e Plus Digital Geiger counter radiation monitor (made in Seattle I think) - and the software can be downloaded here <https://www.gqelectronicsllc.com/comersus/store/download.asp>

I am still experiencing attacks and I don't know if it's a coincidence but after each of these high radiation readings I experienced increased loss of hair (hair falling out). Like I said, there are other weapons being used, including, I have been led to believe, ultrasonic weapons, with the intent to murder with cancer.

What do you think about the idea of police collecting dosimeter data from my geiger counter?

To clarify - I have registered two extremely high radiation readings on my Geiger counter, one racing over 1,250 CPM and staying there for a full minute, and another over 1,000 for several seconds. There have been other days with unusually high nuclear radiation readings, though not as extreme. Shortly before all of this happened, a laptop PC was stolen from my apartment. This is another thing that's been going on - regular thefts from my apartment, which I've tried to address in different ways, including changing all the locks, with no success. Most of the time the thefts are not of items of value but more evidence-related - medical records, journals, and in some cases, the equipment I've been using to measure unusual wireless frequencies. Often items are returned weeks later, usually to a different location, and often in a state of disarray or only partially complete. This is all part of a bigger pattern of harassment and disruption of my ability to keep records and clearly document the things I've been dealing with. The reason I mention it now is because it, along with the types of wireless attacks I've been experiencing and documenting, and this giant and very obvious cloud of drones outside - as well as other information I have - points to these attacks being linked to intelligence agencies. CIA, FBI.

The reason the laptop theft is significant in this regard is that my Geiger counter software is PC only. My understanding is that the danger of radioactivity is usually measured in sieverts - a dose of radiation over a period of time. The Geiger counter is showing radioactivity spikes in real time, but within the Geiger counter is a dosimeter which collects information about the accumulated dose of radiation. This is the information I'm unable to access without a PC and associated software. It makes me wonder if the laptop theft had something to do with sabotaging my ability to collect dosimeter information. A preemptive strike.

Because these radioactivity measurements were far outside the norm, and because the radioactivity levels in general have been outside the norm, I want to document what happened over these past several days so I see the full picture, and keep the information available for evidence. This has to be done on a PC computer with Windows software, which I don't have, and it needs to be done before the information on the Geiger counter is overwritten.

I do understand and accept that this situation is unusual, and that the types of data and analysis of the data might be outside the normal range of what police are accustomed to, but my hope is that if you could help me simply document that this attack occurred, then at least the data has been downloaded, documented, and is available for analysis at a later time or by another agency. I'm hoping you will be able to help me with this.

It is my understanding that behind these attacks is a specific intent to cause a fatal brain cancer and/or other type of cancer. There are various motivations for this. Time is of the essence.

The reason I'm sending these images now is they keep disappearing off of my hard drive and Google drives.

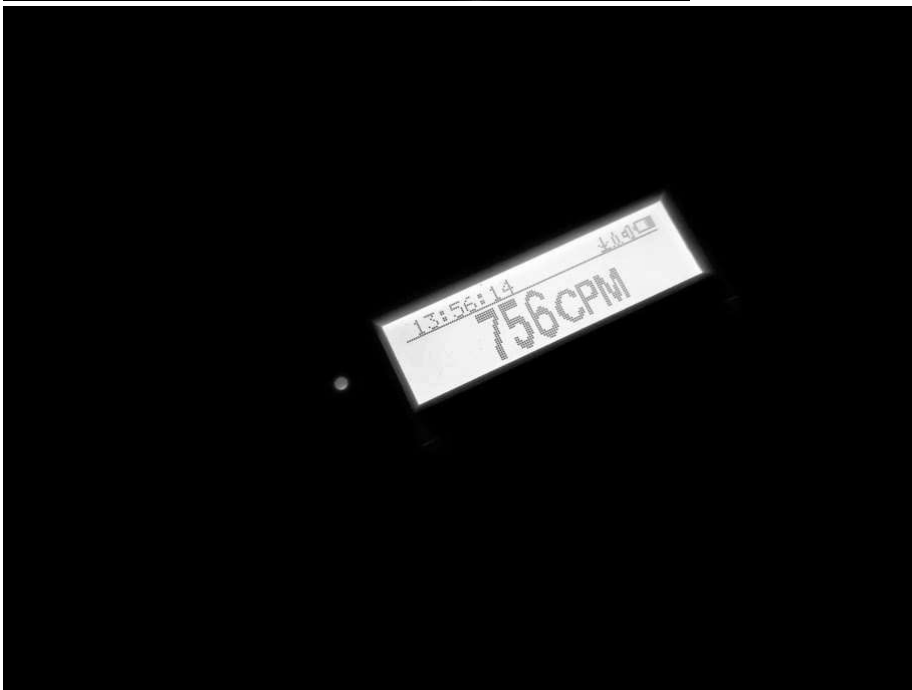

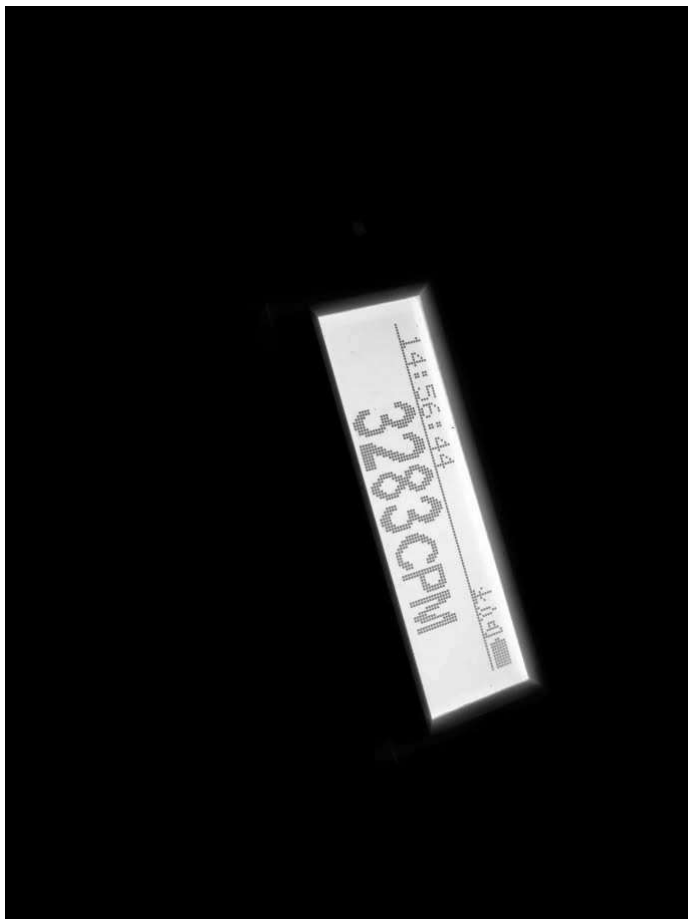
