The following are a list of crimes and torts against me that have either been conducted, facilitated, or ignored by the FBI. They are involved in similar activities targeting me, Erika Katrin Meyer (Erika), my daughter, Brook Morgan Thompson (Brook), and against my late husband, Christopher Lynn Newman (Chris). This was after years of deliberately preventing him and me from professional advancement in our careers via a number of means including blacklisting, libel, deliberate introduction of certain drugs, and frequency-based biomedical attacks. I believe that the FBI and CIA deliberately brought about Chris' death via cancer and frequency-induced torture. I also suspect that this activity is fairly well-known, and financed, and that the reason I am unable to find legal assistance is not only financial, but that everyone feels threatened by this behavior.

It has taken some time to understand the full scope of what has happened, and who was behind it. I did not realize that the FBI was not just ignoring my pleas for help, but actively taking part in or possibly spearheading the crime, until after Chris had died from cancer.

I have done a Freedom of Information Request with the FBI for both Chris and myself which has returned no results; however, I believe this is a cover up. This is really a very large crime that I'm forced to treat as a number of torts because the Department of Justice has abdicated its role in law enforcement. How to do this without legal assistance is tricky. For example, I'm forced to treat medical malfeasance, torture, and murder (crimes) as medical malpractice (torts).

Also, because the crime is so large and has been going on so long, there is a limited amount of detail that can reasonably go into this complaint. I can provide additional evidence and other specific details as needed.

The primary vehicle for creating cellular damage seems to be the use of wirelessly operated piezo-electrical biomedical implant networks. There are a number of ways which I have been able to determine and show evidence, that this is going on, and I've tried to report this numerous times to police, doctors, and the FBI without success. In fact, attempts to report, address, or seek legal protection from this crime seem to lead to retaliation in the form of defamation and increased attack.

## **Torts include**

**Intrusion into seclusion -** I have gathered considerable evidence that there has been surveillance, recording, and broadcasting of activity in our private spaces including bedrooms, bathrooms, home offices. This includes my daughter's private spaces as well.

Public disclosure of private facts – including but not limited to medical information

False light invasion of privacy - much of this surveillance, surveillance broadcasting, and associated storytelling appears to be specifically intended to portray us in a false light, as part of a larger defamation campaign. This may have been the excuse behind both preventing Chris' professional advancement, avoiding addressing the crimes and torts when I originally sought legal assistance in 2014, and may have also been the excuse behind murdering Chris, as well as an attempt to justify the brutality of the murder. It is also likely the excuse made to torture me

and my pets, and to endanger my life, and to harm and endanger my daughter, Brook.

## **Medical Malpractice**

- deliberate misdiagnoses made with intent to harm both through preventing proper care of injuries or through defamation of character (Erika)
- concealing and/or misdiagnosing medical conditions with the intent to bring about additional harm, suffering, and death (Chris, Erika)
- falsified, colorized, medical chart notes (Erika and Chris)
- biomedical devices non-consensually and covertly placed inside our bodies with intent to harm and kill, refusal to investigate or address this issue (Erika, Chris, Brook)

I have detected frequencies emitting from these, presumably piezo-electrical biomedical devices in nearly every part of my body including my eyes, ears, nose, gut, throat, scalp, white resin fillings in my teeth, and in the extraction cavity of tooth 14 (now presumably embedded in bone). I have reason to believe there is at least one implant in my cervix. They are literally everywhere. Chris and my daughter Brook both have had chronic health issues consistent with attacks from these devices.

**False Imprisonment** – includes community-wide organized stalking, harassment, sabotage. This was most evident between 2013 and 2019, though I think it's been going on much longer. There was a kidnapping incident staged as a medical (psychiatric) hold in Sacramento, California January 27-February 1, 2014, followed by ongoing stalking and veiled threats, including from an agent or employee at the Portland FBI office on January 25, 2015, of another abduction, if I were to pursue my complaints.

Assault and Battery (torture) - via frequency-based (directed energy) weapons, biomedical implants. This has been going on, in different ways, and to different degrees, over my entire life. Before 2017 I didn't understand that I what I was experiencing biomedical and radiation attacks. Before 2019 it wasn't clear whether, or the extent to which the local hospitals were involved. Before 2021 I didn't understand that the FBI was involved. These are biomedical weapons systems being used not just on me, but on many people, possibly worldwide. I've described in detail elsewhere the basic framework of how the weapons work, some of what they can do, and who seems to be operating them and/or covering them up.

**Harm and killing of pets** – all of my pets going back to childhood have either been tortured or killed (usually both) with biomedical implants. Having witnessed this kind of thing again and again, and experienced these attacks myself, I've become familiar with the patterns. I only have one remaining pet, a cat named Roxy, who is currently being harmed and tortured daily with what appears to be microwave weapons attacks.

**Fraud** - with deliberate intent to put me, Chris, and my daughter in harm's way. Included "honeytrapping" or romantic fraud (Chris and my daughter); music business fraud, in Chris case,

going back to the early 1970s. My daughter was the victim of a honeytrap between 2018 and 2021, though she may not understand this. Beginning in 2014, shortly after I began to discover a pattern of entertainment industry linked malfeasance, there was an active effort made to separate me from my daughter and to limit our ability to communicate with each other. In my case, it appears every boyfriend I had before I met Chris (1984-2005) was a honeytrap, and every girlfriend and wife he had before he met me was also a honeytrap working on behalf of an outside entity with malicious intent.

There has also been a lot of professional fraud, especially in Chris' case where he was lured or coerced into signing fraudulent contracts with record "labels" whose entire existence seems to have been designed to entrap, deceive, and bury his work. The primary label associated with this activity was Flying Heart Records run by Jan Celt, though there have been others. All of these very small label appear to be linked together, and are likely financed by outside sources.

**Blacklisting** – both Chris and I were prevented from professional progress in a large-scale, coordinated fashion. Medical malfeasance came into play here as I was often made sick in order to sabotage my ability to stay gainfully employed, and Chris was harmed when he would try to record albums or play live shows. I continue to be professionally blacklisted, and Chris' musical catalog is still very obviously blacklisted.

**Intellectual property theft** – Simultaneously with us being blacklisted, our creative works have been stolen and used to "inspire" other artists and writers, many of whom made millions of dollars. Some of this can be clearly shown, though the majority of it would be difficult to show without more information. There has been a regular systematic tampering and destruction of evidence around this issue.

**Trespass to chattels** - our belongings were regularly stolen, especially creative works. Chris notebooks, letters, prior to 2015 have all gone missing. Some of my journals and many of my photos have gone missing. Some of these materials, especially those taken from Chris, would probably reveal some significant information regarding malfeasance, fraud, and intellectual property theft.

**Evidence tampering** – homes and apartments have regularly been entered and paper records including medical records and documentation of investigatory activities have been removed disrupted, or damaged. Digital files also regularly cropped or deleted from computer storage and even cloud storage. Sometime in 2020 two of my YouTube channels vanished without cause or explanation. Both deleted channels contained original homemade music videos, some of which had been imitated or evoked by top recording artists.

**Defamation** – There has been defamation in medical records of every provider I've seen. There has even been defamation of me in Chris' medical records. I have seen, and unsuccessfully tried to remove defamatory content found on third party websites (Go Fund Me), and I believe there has been defamation facilitated and distributed on platforms kept secret from us, monitored or controlled by federal agencies such as the FBI and/or CIA. These secret platforms may also be partially responsible for intellectual property theft by distributing content and creative works without permission or compensation.

Negligence – Police and FBI have repeatedly refused to follow up on my reports of crime.

- Jan 25, 2015 attempted to make a report in person to the Portland FBI office
- May 22, 2015 attempted to make a report in person to the Portland FBI office, followed with a letter to Washington D.C. office (dated May 18). In this visit I explicitly told the intake worker that our lives were in danger from directed energy attacks
- Nov 28, 2019 online tip form fbi.gov
- Dec 9, 2019 online tip form fbi.gov specifically addressing radiation attacks aimed at a dental crown
- July 30, 2020 phone call made to Portland FBI office reporting directed energy attacks aimed at my heart
- July 16, 2021 online tip form fbi.gov reporting my daughter and myself as endangered human trafficking victims
- Sept 21, 2921 phone call made to Portland FBI office reporting extremely high radiation readings on Geiger counter (3000+ CPM)

When the FBI refused to help me, I filed Civil Rights violations complaints with the Department of Justice both through their online form (February 17, 2021, report record number 55091-KTM) followed by a detailed letter dated April 5, 2021. After not hearing back and with Chris and I both experiencing ongoing directed energy attacks, him as he was sick from cancer and me while I was caring for him, I sent a follow up email (67017-PDP), stating "I am in danger and so is my daughter. We need to be protected from this crime as soon as possible. We need medical care that we can't get because of corruption. Please help quickly." Other than the automatic responses giving record numbers, I never heard back from the Department of Justice.

Wrongful death (murder) – Chris was tortured and murdered via wirelessly accessed biomedical implants. There is a tremendous amount of evidence pointing to this. I have known at least since 2017 that these were present and a risk, and as I said, I have been trying to report it as a crime. When I spoke with the FBI intake worker on May 22, 2019 I told her specifically that our lives were in danger. I put that same information into the letter I sent. On June 3, 2019 Chris was hospitalized with heart failure which he had as a result of directed energy attacks to and manipulations of his heart. Meanwhile, he was also being given cancer via radiation directed at organs adjacent to implanted devices in his gut. He was hospitalized again with severe pain on January 5, 2021, then diagnosed with terminal cancer. Based on Chris' medical records, there are reasons to suspect that this cancer had actually been detected when he was in the hospital in June 2019, but ignored. While Chris was sick with cancer, he was tortured with biomedical implants and weapons. I have evidence of this. Chris died on May 9, 2021. Though he had cancer, he did not die from cancer; he died because his heart was stopped electronically. I've documented all of this and attempted to report it to police. Police refuse to take reports from me, saying that it's because I am mentally ill. This of course is supported by the falsified and defamatory medical records as well as the kidnapping which happened under false pretenses. Frequently, presumably as punishment for even attempting to report crime, there are suggestions or threats of another involuntary medical hold. Regardless of the falsified paper trail, which is extensive, the actual

evidence does not support my having this type of mental illness.

**Personal injury, negligent endangerment** – I have experienced a number of permanent injuries linked to radiation based directed energy attacks to my legs, lungs, head, gut, skin. I have permanent disfiguring marks on my face, torso, and legs from years of these attacks. My teeth are cracked, with dentists falsely claiming it is from tooth grinding. I have been attacked in the head and lungs for years, in what seems to be an intent to murder via radiation-induced cancer. I have experienced radiation attacks to my heart. More recently I've been suffering from attacks to my urinary system and gut. This technology is capable of creating everything from falls, to car accidents, to strokes and aneurisms. Thus, the biomedical implants themselves are the problem.

Pain and suffering – how do you describe, much less put a price value on, a lifetime of deliberately caused emotional and physical pain and suffering? I have kept journals for most of my life, and I have detailed quite a bit of emotional pain caused from being honey trapped, from watching my animals be tortured and killed, and from professional blacklisting while trying to support myself and a child as a single mother. I was a single mother because my daughter's father was a honey trap who engaged me in a fraudulent relationship. This obviously caused her to suffer as well, but she's also been tortured with biomedical implants. Since 2014 we've been robbed of the close relationship we used to share, and because that happened immediately after I began to recognize signs of malfeasance, I have been unable to sufficiently warn her of the dangers around her, due to the layers of fraudulent relationships built around us. I suffer knowing my loved ones have been suffering from biomedical and biological attacks (including things like the deliberate introduction of pests and parasites like bedbugs and head lice) and psychological manipulations. All of us have suffered from deliberately introduced chronic illnesses. Chris suffered tremendously from blacklisting, and self-blame when he couldn't succeed or defeat a number of medical conditions including obesity and addiction that were linked to biomedical as well as deliberate psychosocial manipulations. There is evidence that Chris' professional failures, and possibly even his death, were directly linked to the success of a number of local and regional businesses including Sub Pop Records in Seattle and Voodoo Doughnut in Portland. There may be other businesses – maybe even billion dollar businesses – with a similar history of profit and professional advancement directly related to participation in malfeasance. Chris was an immensely talented and hardworking artist who was, through no fault of his own, never able to support himself or his family, never able to completely free himself of addiction, and who died believing he had failed professionally, and that it was his own fault. And I was forced to watch him tortured as he died, in the same way my dog had been tortured in the 1990s, by control of his bladder so he was unable to urinate. Chris screamed in agony and I couldn't help him. After this happened, I started to experience bladder issues, making me realize this kind of manipulation had been done to him since we met in 2009. Chris and I had dreams of making records, touring with our band, going on vacation, having a home where my daughter could visit - all of which could not be realized because of this crime, and because once I'd discovered the crime, because of the abject refusal of the FBI and other authorities to bring the crime to an end. Chris wanted to be, and strived to be in good health, and so does my daughter, and so do I.

## **Constitutional violations**

1st amendment violation - retaliatory behavior resulting from attempts to speak out, seek

redress for grievances. Attempts to force certain religious world views on us. Use of bribery, force, or coercion to enforce blacklisting activity and to prevent others from speaking to or otherwise associating with us freely or honestly.

**4th amendment violation** - surveillance, breaking and entering, disruption and removal of property without a warrant, even physical violations (implanting biomedical devices for purpose of ongoing surveillance and attack)

**5th amendment violations** - allowing others to surveil us and then secretly use what they gather or create as an excuse to "punish" (assault, murder)

**6th amendment violations** - I suspect there's been a promoting of the idea that all of this surveillance and trespass is a "legal process" when in fact it is a violation of constitutionally protected due process under the 6th amendment

**7th amendment** - the only reason I haven't brought suit earlier is because first, even though I knew I was a crime victim, it's been exceedingly difficult to detect the full nature of the crime and who is behind it. Police and FBI refused to investigate, and everyone else refused to speak or deliberately misdirected me. This has included my family members, Chris' family members, and attorneys who I've attempted to contact. This is why, regardless of how much evidence I have of a very large and serious crime (and collection of torts), I'm forced to create my own case, so far without assistance from police or legal counsel.

**8th amendment** - all of us - Chris, me, and my daughter - have been tortured via biomedical implants. Often the torture is disguised as medical conditions. Our pets have also been tortured and killed. Chris was brutally tortured in his last days, and because the torture was done with biomedical implants, and because everyone I reached out to ignored my pleas for help, I was unable to help him, no matter how hard I tried.

**13th amendment** - we have been imprisoned and financially blacklisted while others have covertly (and in some ways, openly) profited from nonconsensual surveillance, nonconsensual human subjects research, and our creative works. This is involuntary servitude.

**14th amendment -** violations under due process clause and equal protection clause. Clearly, we have not been given equal protection under the law.

**Desired redress:** for the reasons stated above (lifelong blacklisting, intellectual property theft/conversion, and biomedical malfeasance) it's unfair to base compensation for Chris' wrongful death on how much he was actually earning. It would make much more sense to look at what others who financially profited from the crime have earned. This includes bands like Nirvana, record labels like Sub Pop, businesses like Voodoo Doughnut and Microsoft.

The current revenue of Sub Pop is about \$8 million per year. The current revenue of Voodoo Doughnut is about \$60 million per year. The current revenue of Microsoft is \$168 billion per year. The net worth of Nirvana is currently about \$450 million. In addition, there seems to have been a massive influx of wealth into Portland and other cities linked to this malfeasance,

including multimillion dollar building projects, home renovations, goods and services, and floods of luxury vehicles. Because the FBI is facilitating rather than investigating these crimes, it's hard to pin down exactly how this finance works, but it seems clear that there is funding coming in from a number of sources, both foreign and domestic. In reality it probably would not be an exaggeration to call this a trillion dollar crime.

With all that in mind, I think that \$300 million in compensation along with an immediate cessation of the aforementioned offenses is an appropriate request. In truth, there are a number of ways that redress could occur. For example, if I were not prevented, as I have been, from hiring an attorney, doing discovery, and seeking appropriate compensation directly from other entities, like those mentioned above, that should be weighed as a factor. However, I've got to contend with the effects of lifelong imprisonment, lifelong defamation of character, torture and cellular damage from biomedical implants, and blacklisting. Equally if not more important than financial compensation is the cessation of the crime, and repair of the medical system. It is not acceptable for hospitals and doctors to be lying in chart notes, to refuse care, to give inappropriate care, or to mislead to a patient because an outside entity has decided that person should be harmed, or that their life should be ended. A person should not be made ill because a biomedical research facility has a new kind of cancer they want to study, or because a powerful entity owes that person money (like legal damages) and would prefer not to pay. All of this seems to be endemic right now.

This is all complicated by the involvement of so many federal agencies. I am aware it's not just the FBI but the FCC, who monitors frequencies, and the FAA, who monitors drone traffic, and the CIA involved in these activities. My focus with this complaint is on the FBI because it is the FBI's duty to protect citizens from crimes such as these, and because I tried to report different aspects of this crime to them at different times, never with any success, and often resulting in retaliation. I would like the opportunity to negotiate not just a financial settlement, but an appropriate and trustworthy medical solution. I believe these biomedical implants have a military source (CIA, probably).

I think that as an American citizen, I deserve to be able to trust my government to protect me, not to harm and exploit me, or to facilitate exploitative behavior on behalf of financial interests. If the FBI is unable to do this, then there should be another federal or military agency who is permitted to step in on our behalf. In particular, it is important to me that the federal government stop ignoring my pleas for help, stop lying to me, and work cooperatively with me toward a resolution that is acceptable to and manageable for everyone.
