

seeking protection from DOJ malfeasance through crime victims rights act

Dear Ms FitzGerald.

I have been suffering for some years from numerous crimes. I have tried to report the crimes to police going back to 2014, and then as they became more serious, to the FBI, going back to 2015, without success. Even in instances where I've been able to collect a significant amount of evidence to support my claims, I've been told by police and FBI that nothing can be done to help or protect me. My complaints are regularly dismissed as nuisance complaints and even as delusional, regardless of the type or amount of evidence I am able to provide.

Based on the refusal of the FBI to address these serious crimes, and based on the types of crimes they are, it's become increasingly apparent that the FBI themselves are taking part in these crimes. The crimes include unlawful intrusions, evidence destruction, and covert but very real and serious forms of battery.

Unable to hire an attorney, I've attempted to file a torts claim on my own against the FBI. This was in September. I understand that I cannot do anything further in this regard until March 2023. However, any attempt to protect myself brings increased retaliation. And that is what has been happening. In an attempt to protect myself, I filed a motion for a temporary restraining order against the FBI with the District Court of Oregon. The motion was denied, and I am now working on an amended complaint. In this process I'm trying to educate myself about how best to present my case, using case law and statutes to make a clearer case for why I require protection from the FBI itself.

I have considered invoking the Crimes Victims Rights Act, which I did not in my first TRO request, in part because I'd been told by Crime Victims Rights Advocacy groups in Oregon that I couldn't invoke these laws if police refuse to take crime reports from me. However, this was before I understood the FBI as being a perpetrator of the crime. Perhaps the federal crime victims protection laws don't have this catch-22.

Another problem with my situation is that I can't necessarily point to any given individual agent or officer as violating my rights, at least not in recent years. When I've attempted to report crimes to FBI, for example, agents refuse to give last names. Having been through this as long as I have, and having observed certain consistent patterns in how things are done, it is really clear that this is not just one or a few individuals committing malfeasance - that it is systemic.

In April 2021 I filed a civil rights complaint against the FBI with the DOJ (55091 KTM, 67107-PDP). There was no response.

In summary, I'm trying to figure out how to evoke Crime Victims Rights laws in a manner which will protect me. I have kept records of all my complaints to the FBI and police. I have a great deal of documentation to support my claims. A lot rests on whether the DOJ et al consider me to be a reliable narrator, but not everything relies on that, as I have scientific measurements and videos made over a period of time that show evidence supporting my claims. It's a matter of being willing to examine the evidence and ask appropriate follow up questions, as opposed to dismissing my claims outright as a nuisance and me as somehow mentally incapacitated.

Can you help me invoke these laws in a way that will help protect me from ongoing harm, or otherwise advise me?

Hello:

The Office of the Victims' Rights Ombuds has limited authority to investigate alleged violations by Department of Justice employees of specific rights established under the Crime Victims' Rights Act (CVRA). These CVRA rights become available to federal crime victims only when federal criminal proceedings are initiated by complaint, information or indictment. You must be "a person directly and proximately harmed as a result of the commission of a Federal offense, or an offense in the District of Columbia," and be a "crime victim" of an offense charged in Federal District Court or the Superior Court of the District of Columbia to file a complaint with this office. 28 CFR § 45.10(a). It does not appear that you are an identified crime victim in a federal criminal proceeding. We cannot assist you.

I am a crime victim. I have reason to believe the perpetrator is, or includes, FBI. I have filed a pro se FTCA claim against the FBI. Now I must wait six months. Meanwhile the FBI continues to enjoy sovereign immunity and I continue to suffer harm. I am concerned about suffering irreparable harm. To that end, I filed a motion for a temporary restraining order in federal court, case no. 3:22-cv-1779-SI

Motion was denied. I have been given until December 30 to amend the motion, which I intend to do.
