May 4 DDA Abbie Tornquist received a letter from AO Erika Meyer stating her animal is being abuse. 2023 DDA Tornguist forwarded the letter to MCAS and requested that a welfare check be done on

12:45PM the cat.

May 4 I called behavioral health to see if Erika has a case worker. 503-988-4888. Call taker stated that at this time it is unknown if Erika has a case worker. However, with the information I provided 2023 3:45PM and reported, they will send someone out to evaluate. Per HIPPA law, call taker stated that she

cannot tell me if Erika has a case worker or not. The owner has belief that the government is using biomedical and wireless weaponry and states that there are devices implanted in her cat "Roxy". Erika has claimed this previously. I arrived at the listed address and could not contact Erika, LBM and noted the cat in question in the window. "Roxy" appeared to be a healthy

weight with no visible injuries.

May 5 2023 9:05AM 5/5/23 I emailed Erika at ekm@seastorm.com as ACO Schiewe had a better response using email. I noted that MCAS vets can exam Roxy if she would like to set that up to email me back.

May 5 2023 9:31AM Hi. I sent a records request through the online form last night, so that I get an idea of who is filing reports with your office. There are a number of things going on, all at once. The lay of the land on this is the following: I maintain, as I have maintained since 2019, that Roxy is being attacked, abused, and deliberately tortured from a remote location, via a wireless biomedical weapons system. In addition, I have made claims that I am also being attacked via the same technology, and that my husband was murdered with this technology. This may sound, on its face, extreme - but that's because it *is* an extreme situation. The truth is, I have evidence to support this claim, including pattern based evidence and empirical forensic evidence. In addition, I have information about how this claim can be scientifically tested by police or animal welfare investigators, either by using basic countersurveillance equipment such as a wide frequency range frequency tracer - like the directional antenna bug detector I used to find wireless signals coming from my own body in 2017 and 2018 - or via some similar type of equipment which would be used by surgeons or biomedical researchers in labs, universities, or hospitals such as OHSU research labs. In Oregon, Police are obligated to arrest animal abusers. They are getting around this by simply saying "I don't see a violation here" and refusing to investigate. This is harming my cat, and it is harming me, not in the least because it means we are not afforded the protection that crime victims are supposed to have under the law. As I wrote in the letter I mailed to Police Chief Lovell yesterday "ORS 133.379 states: 'It shall be the duty of any peace officer to arrest and prosecute any violator of ORS 167.315 (Animal abuse in the second degree) to 167.333. ORS 167.315 is one of the statutes being violated when Roxy is attacked and tortured via biomedical weaponry." Roxy was at the vet on April 27, with extreme gastrointestinal distress which she'd been suffering for nearly a week. The first day of her gastrointestinal problems, I also suffered gastrointestinal problems. This is a typical pattern and it happened with my now deceased husband and me as well. Often we would have the same symptoms at the same time. Until last week I may have had some reason to suspect - but no real reason to believe - that the Portland Police Department and/or the D.A. is directly involved in covering up, benefiting from, or facilitating these violations. As of this week, this has all changed. Erika

May 5 2023 9:35AM I responded to Erika's email by again noting that if she wanted Roxy seen by one of MCAS vets we can set up an appointment.

May 5 2023 1:00PM I provided Erika with the option of free vet care at MCAS if needed. Per Erika "Roxy" was at her vet on 4/27/23. I also notified Behavioral Health for Erika's social worker to follow up.

May 5 2023 3:02PM Erika stated that she brought "Roxy" to Banfield on 82nd for care. I called and confirmed care was provided. (vet report attached) I noted to Erika if she needed any further vet care to reach out. RECOMMENDATIONS: case closed as "Roxy" was provided vet care, Owner has been given the option of further vet care through MCAS as behavioral Health was contacted

Dear District Attorney Schmidt:

I have a cat which has been tortured every day for over a year by biomedical and wireless weaponry. I have collected a great deal of evidence to show that this is what is going on. There are ways to confirm that this is what is going on, and to determine who is behind it. It would involve using a bug detector with antenna (wand style) that picks up signals from wireless devices such as hidden cameras, hidden microphones, etc. It is possible that an RFID scanner would work, though I don't know.

I would like a police officer to meet with me, to collect some of my evidence, most of which is 'electronic files showing the injuries and how the injuries occur. I can pass these on via an external drive (ideally the police dept can provide me with one) — or online via a shared cloud account.

The police have regularly refused to take my complaints seriously, seem to avoid answering when I call, or sometimes I get cut off, etc. I've suffered a lot from crime that police will not investigate.

I cannot stand to see my pet cat abused in this way. It is clearly abuse, but it's being done remotely. The police should have the proper gear to do this kind of investigation, and if they don't, they can get it from the FBI.

Also, I think any facility conducting biomedical research, such as OHSU, should be able to identify, using similar equipment, but for biomedical research - if the cat has implanted devices in her ears, gut, or elsewhere.

Please advise me on how to work with the police so that this crime is properly documented and investigated. The cat is suffering tremendously, and being forced to witness animal abuse is abusive to me as well.
