Dear Records Custodian,

I am the Plaintiff in a number of cases involving conspiracy, and intellectual property theft, and fraud. Although I'm still learning about what has happened, it is likely that one of the defendants, and possibly the primary defendant in these cases, is going to be the FBI. One of the charges against the FBI will be 4th amendment violations against warrantless search and seizure.

In the course of these offenses, there has been a tremendous amount of evidence tampering and spoilation. Some of this evidence tampering has occurred in my Google accounts including Google Drive, Google Photos, Gmail, and YouTube. The pattern has been consistent and does not appear to have any connection to more obvious issues of password security. It appears that someone at Google, or with access to Google from the backend, has been able to access and alter data on my accounts, and in some cases, delete accounts. This, by the way, has not only occurred with Google – it's happened with Facebook and Twitter as well – but Google is unique in that it offers a way to create and store media, such as one would do in order to back up information for a court case. Most of the problems with evidence spoilation online have been associated with Google accounts. There is simply no good substitute for what Google and YouTube offer in terms of archiving and documenting data online.

Data spoilation on my Google accounts seems to be targeted toward documents relevant to these court cases. In addition, two YouTube accounts vanished sometime in 2020. These accounts contained irreplaceable original works which were also relevent to these cases. The usernames were, as I recall, skullmanrecords and boofrogrock. I can give more information about all of this as necessary.

My intent with this letter is to alert your legal department to this issue, to let you know that there is this ongoing sabotage/evidence spoilation issue in my accounts, and that based on my observations of this phenomenon going back to January 2014, I believe it is the FBI who is the culprit. If it isn't the FBI then it is Google. These will be conspiracy charges. The evidence spoilation is related to far more severe crimes, including, evidence is pointing to, targeted murders by the FBI.

Because there are pending court cases, I ask that Google take the following steps to stop this evidence spoilation.

- remove warrantless access to Google accounts by the FBI
- take steps to ensure that my accounts specifically are not being tampered with by intelligence agencies or employees at Google who may have been contacted by outside interests

The following are a list of emails that I use or maintain on Google. Most of these have attached drive, photos, and/or YouTube accounts as well.

There is another account which is associated with a YouTube channel which has not been deleted, but which I have lost control of, due to no longer having access to the password or associated phone number, 503-752-5219, and that is napalmbeachpdx@gmail.com – I would appreciate regaining control of that account if at all possible; if not, I ask that it be preserved, because it too contains evidence useful in these court proceedings. The content on this account is similar to the two YouTube accounts that were deleted, boofrogrock and skullmanrecords.

If you need more information from me, or if you need me to take additional steps to secure these accounts, and the content on them, please let me know. If there is any way to recover data from the deleted YouTube accounts **boofrogrock** and **skullmanrecords**, or if it can be ascertained WHY and HOW these accounts were deleted, that too would be of interest.
