Subject: Touhy Request for Multnomah County Case No. 23CV20288

I am the self-represented plaintiff in Multnomah County Case No. 23CV20288 against the City of Portland. This request is related to a Subpoena Duces Tecum for production of documents from the FBI which will be mailed on August 7, 2023.

The background to this complaint is an ongoing situation in which the following appears to be true:

1. I am, and have been for approximately the past two decades, been unable to find or keep gainful employment
2. I am, and have been, unable to make money from my own work products through self-employment or business ownership
3. There have been numerous signs of unlawful surveillance through fire sprinklers in my private residence as well as in locations such as retail dressing rooms, doctor's exam rooms, hospital rooms, school and gym locker rooms, and public restrooms
4. There have been numerous signs of intellectual property theft and distribution of unlawfully acquired surveillance data

5. There have been persistent thefts of personal possessions including letters, diaries, and photographs, and signs that these possessions were distributed or published
6. I am experiencing a number of disturbing, dangerous, and difficult to explain medical issues
7. There are persistent patterns of factual fabrication, specific sorts of exaggerations, misleading information, and false and damaging diagnoses in my medical records, apparently unattached to any given provider or medical system
8. I am unable to find legal representation for any issues relating to this, either on a contingency basis or as a paying client
9. Since January 2015 I have attempted to make several crime reports to police and to the FBI related to these issues. FBI has never followed up with me on any report. FBI also has told me my only options are to report to police or to seek help at local hospitals, and they have persisted in this position even after I told them that police and hospitals both say they are unable to help me address issues either of surveillance or biomedical abuse, and even after I have told the FBI that the hospitals appear to be complicit in the abuse.

In addition to all of this, my husband was tortured and murdered, partly through hospital malfeasance, and my pets are being tortured and killed. Case No 23CV20288 is brought because of this latter issue, due to the Oregon law that mandates police arrest and prosecute any violator of Oregon's animal cruelty statutes (ORS 133.379). Fourth amendment violations are also alleged, as the police have also refused to investigate any allegations associated with surveillance, surveillance distribution, or biomedical malfeasance. In other words – based on patterns of attack, it seems clear that my cat is being harmed via the same type of biomedical weapons that are being used to harm me, have been used to harm my daughter, and were used to murder my husband via biomedical torture, heart disease, and cancer.

This request is brought in order to better understand the why Portland Police have

1. failed to investigate my reports of crime and
2. showed signs of having foreknowledge of abuse of myself and/or my cats

Questions for the FBI, with additional clarification regarding relevance:

1. What, if any, are the mandatory duties of the FBI in the State of Oregon? Please provide

references to, and/or the text of any relevant statutes or documents.

This question is necessary to evaluate how potential interactions between FBI and Portland Police Bureau have affected the police bureau's behavior with regards to these offenses. It will also help me distinguish between mandatory duties of police, versus mandatory duties of the FBI with regards to crimes of this type. Information about statutory and mandatory duties of the FBI is difficult to find through normal internet research techniques.

2. Please explain or provide documentation explaining why the FBI and police have refused to follow up on my evidence-based complaints of wireless biomedical weapons attacks.
3. Please provide any documents regarding phone calls, letters, tip form submissions, or in-person reports I have made or attempted to make with the FBI including internal communications, communications to and from police, communications to and from doctors, communications to and from City of Portland employees, state legislators, or other political leaders, and communications to and from community informants and my own family members.

This is to help me determine the organizational and financial structure of these offenses.

4. Please provide documents of any internal or external communications related to my attempts to report surveillance to Officer Zachary DeLong on January 20, 2014, including any documentation regarding that incident which took place in the months leading up to, and the months after the January 20, 2014 attempted mental health hold occurred.

This is part of determining whether the non-response of Portland Police Bureau and/or FBI to crime reports is related to mental health records or related documentation and/or correspondence, or whether it is related to allegations of unlawful surveillance, or both.

5. Please provide the full name of the intake officer with whom I spoke at the Portland FBI office on January 25, 2015 and provide documentation of any reports made by him, or instructions given to him.

This officer who would neither give me any identifying information nor take a report from me insinuated that because I was alleging deliberate electronic interference in personal devices as well as inappropriate surveillance I was paranoid and potentially in danger of another involuntary mental health hold. Identifying this officer may lead to discoverable information which will help determine whether my attempts to report surveillance or biomedical-based crime are actually leading to case files alleging paranoia, anxiety, delusions or related mental health issues.

6. Please provide documentation of any communications with Portland Community College

employees regarding hidden cameras on the PCC Southeast and Cascade campuses, including my handwritten complaint to the Title IX office made in or around early July 2015.

This is part of determining whether there is concealment by Portland Police Department and FBI of widespread surveillance on the Portland Community College campus; it is part of determining whether allegations about my mental health by PCC's Office of Equity and Inclusion is related to my handwritten allegations about surveillance in the Cascade Campus gym locker room and women's restrooms; and it is related to issues of evidence spoliation, as that handwritten letter was not included in the file associated with my Title IX complaint.

7. Please explain or provide relevant documents explaining who is responsible for the network of high-altitude drones operating in the skies over Portland, Oregon, and what their purpose is.

This question is asked because due to pattern-based evidence, it clear to me that these drones are associated with monitoring and accessing non-consensually implanted biomedical devices, including those inside my own body, and inside my cats. Therefore, who is operating this network of drones, and under what instructions, are at the crux of this case. These drones are largely invisible, but when lit at night, mimic stars.
