Dear Criminal Division,

Thank you for your letter dated July 23, (Reference # NM302133285). The letter began “Thank you for writing the Department of Justice, Criminal Division.” I do not recall having written to this office. I did send a letter to Attorney General Merrick Garland dated July 12, and it looks like this may be the letter to which you are referring. The letter was intended for the US Attorney General.

While it is true that my letter to AG Garland mentioned civil rights violations, it also described organized crime being run by the FBI, incorporating local police and sheriffs’ departments, and all medical institutions. This crime involves the pervasive use of biomedical weapons – wirelessly accessible piezoelectrical biomedical implants – to unconstitutionally surveil, injure, and murder American citizens. I pointed out that I am being physically harmed by this and that my life is endangered by this activity. I can show evidence that these weapons exist, and that they have been used to harm me and my loved ones. I can also show evidence that I and my loved ones have been sexually and otherwise exploited through surveillance systems and biomedical manipulations covered up by police and FBI. Bringing a safe and scientific end to such activity is almost certainly beyond the purview of the Civil Rights Division.

In fact, as described on page 2 of the original letter, in 2021 I filed two complaints with the Civil Rights Division (55091-KTM via email & 67107-P). There was no response to either complaint. By now, three years later, I have a better idea of the scope and focus of the crime. It is a conspiracy to commit murder, and it is murder for hire. People in important positions: doctors, police, administrative inspectors, etc. all seem to know that they are expected to cover the crime and throw sand into my wheels. They systematically ignore evidence, deny the seriousness of my claims, deny the reality of my claims, treat my concerns as unimportant, and slow down every process in order to allow these weapons to work. All of these individuals know – and certainly everyone in the US Department of Justice knows – that this crime exists, and that much of it is focused around me and my household. To kick my complaint down to an anonymous

administrative level, to encourage me to be “patient” – knowing that I’ve been trying for 11 years to bring this crime to an end – are all patterns typical of the conspiracy.

In short, the crime functions not because it is unknown, but because of omerta, lack of accountability, financial manipulations, and the aforementioned wireless weapons system.

I understand that there are other complicating issues. For example, there is evidence pointing to direct involvement by presidential administrations including Obama, Trump, and Biden. There is also evidence pointing to these three presidents themselves having been biomedically affected by such weapons, complicating the situation further.

The fact is that I have ample evidence to show that I have a network of biomedical devices in my body, and I also have evidence that these biomedical devices have been used to physically harm me, and that such technology is regularly used to murder.

And as I said – the existence of such activity is well-known, as is the fact that murders have occurred this way, as is the intent to murder me and others. All three of these things are known to many. To deny this or engage in ad hominem attack against me as a means to discredit my allegations, or to act as if this allegation is simply untrue are typical delay tactics. This is a complex issue that needs to be handled at the highest level, by someone with authority and accountability. That is why I sent the letter to the US Attorney General.

My understanding of how the US Dept of Justice works, is that in most crime situations under federal jurisdiction, as well as in situations where the latest scientific analysis is required, the FBI would be the office who would handle this.

In this case, the FBI is running the crime. Thus, neither the FBI nor anyone who has been involved in the crime or who has a vested interest in the outcome of any part of this conspiracy should be asked or expected to investigate or address the crime. To be more explicit: because of the nature and extent of this conspiracy, all normal channels of law enforcement investigation are inaccessible.

Furthermore, because of the nature of the crime, there is a significant danger in delay. People suffer and people die every day from the use of these weapons.

It should not be difficult to demand and ensure that the FBI cease an unlawful activity. In this case, they are accessing human bodies through an established network of biomedical weapons. This alone is arguably extremely abusive as well as a violation of constitutional rights. But the FBI has abused this power to the extreme, deciding who will live or die, and even worse, making these decisions based on finance.

To whatever extent the FBI is colluding with other agencies or interests in this activity also needs to be addressed. The continuation of this crime is an affront to human decency and needs to be seen as unacceptable.

This situation needs to be brought to the explicit attention of the United States Attorney General. There needs to be accountability, and that accountability needs to be attached to a name and position.
